NCSG Region 1 Report -July 2009

The months of June and July offer annual gatherings for chimney professionals in the northeast.

Attendance at June's gathering brought sweeps and vendors together from NH, MA, ME, VT, NY, NJ and PA. Discussion centered around the recent fiscal necessity to eliminate the position of technical director from staff with the overwhelming sentiment being the position was a most valued NCSG membership benefit – knowing when faced with a problem in the field, unbiased technical support was just a phone call away. Concern was expressed that the volunteers comprising our technical advisory board may not be available in the hour of need. Suggestions were offered to explore other cost saving budget cuts. While attendees were not yet in receipt of NCSG ByLaw Amendment Ballot, there was discussion regarding the necessity of the proposed changes.

The city of Keene, NH, is forming a committee to address implementation of an EPA Great American Woodstove Changeout program. City planners are taking a proactive approach to a "heads up" from NH-DES that the results of air quality monitored over the past two years are heading towards non-attainment status. The city is located in a "bowl"; analysis of pollutants have identified wood smoke as the offender. As the Woodstove Changeout program has never been implemented in the state of NH, Keene will be modeling the rebate program on the trials and tribulations of Vermont's recent statewide Woodstove Changeout program. The importance of inclusion of utilizing certified professional installers within the parameters of program was shared with representatives from NH-DES, EPA and potential subcommittee members.

Membership Outlook

As reported last quarter, NCSG membership in Region 1 appears to have declined by about 3 ½ % over the past year -the declining economy being stated as a driving decision maker.

Currently, member sweeps total 2 in the state of Hawaii, 1 in Arizona, 4 in Nevada, 4 in Utah and 59 in the state of California. That's a total of 70 region eight members. That's an eight member decrease since my last report in May 2009, and a 33% lose of members from this region alone since May of 2006.

Many, if not all parts of the region have been hit hard by the currant financial crises and this has certainly impacted the chimney sweep trade. Consumers are loosing their jobs, credit is restricted and the loss of equity in homes only adds to the slide.

The "Golden State Chimney Sweep Guild" remains the only state guild within region 8. The GSCSG is held its 27th annual convention and trade show in Bakersfield, CA last month. There was four days of education available to sweeps yet only eight members bothered to show up. Member numbers are down significantly in this regional guild as well with only 48 currant individual members listed on the web site representing only 40 companies state wide. The GSCSG dose a great job keeping local sweeps connected and providing workshops and educational opportunities to sweeps in region eight. Members must participate in these events or this organization of over 25 years will become a memory.

Bylaws Committee- Bylaws Amendment vote still pending

Vice President's Report- I would like to have training that discusses duties and responsibilities of Board members, corporate structure and communications between the Board and Staff. There seems to be some misconception about our roles and responsibilities as Board members. This could be something as simple as a PowerPoint presentation on CD, sent to all Board members.

TAC Report-

Royal Edwards' last compilation of TAC calls was in March of this year. It showed that TAC members had received a total of 20 calls, presumably during the month of March. There was no indication on this report of how many calls Royal handled personally.

Since stepping up as acting chair of this committee on May 7, 2009 I have logged a total of 23 calls reported being received by various TAC members.

I have a few recommendations for the future of TAC:

- Technical assistance to members should be converted to a Frequently Asked Questions page in the Members section of the website. An e-mail address should be provided for additional assistance.
 - Since most, perhaps all, manufacturers and/or distributors offer technical assistance for their products a full time, on call technical assistance service not needed. Call volume supports this position.
 - o The current structure of the TAC, and the lack of consistent recording and reporting of calls, may leave the Guild open to potential liability. A web/e-mail based system would offer the benefit of recording all web page vists, e-mail requests, and replies.
- The TAC may need to be reduced in size. An SOP should be published, and should require that members actively fulfill obligations of membership, or they will be dropped.
- Technical articles for Sweeping are often hard to find. I recommend we offer a \$100 stipend to the writer of any technical article published. I further recommend a \$50 stipend to the writer of any Q & A published. A small announcement could be published in Sweeping each month announcing

congratulations to that month's winners. I believe if we advertise this it will encourage members to submit articles. Since money is paid only when the article or Q & A is published we would budget \$2200 per year for this.

NFPA 31 Report

I was unable to attend the last NFPA 31 committee meeting because of a scheduling conflict. NFPA moved the meeting to the same time as the New Hampshire Association of Chimney Professionals Sweepsfest for which I was the keynote speaker. Below is the report I submitted to NFPA as the Chair for the chimney liner sizing sub-committee.

Flue gas liner vent sizing sub-committee

On March 23, 2009 the sub-committee on flue gas liner vent sizing held a meeting at Brookhaven National Laboratory, Upton, NY. In attendance was John Pilger, Aaron Clark. Ed Angelone, John Levy, John Batey (via phone), Tom Butcher and Roger McDonald.

A discussion was held on the history of the current sizing charts.

Chimney failure, flue tile damage, chimney location and wet cycles were also discussed. Dr. Tom Butcher was very interested with GTI's Fluent (sp?) program for calculating vent sizes. The sub-committee talked about requesting funding for the research with NORA, NHRI and NFPA. The Gas Technology Institute (GTI) TC 610 task force is doing a review for ASHRAE and Dr Tom is going to ask GTI for a Summery Proposal to provide independent validation of Appendix E in NFPA 31 through the fluent program and laboratory testing. Ed Angelone was to assist Dr. Tom.

As part of identifying future potential candidates for board service I am asking all directors to be thinking about individuals who would be good potential candidates for board service with the goal of having two people submitted by each director. The ongoing work of the GC will be to develop a list of potential candidates for board and committee service. Another part of developing this list will be through membership surveys listing individuals who have indicated they are willing to step up and serve.

I ask all directors and committee chairs to think ahead as to who you are mentoring to be your replacement at some point in the future. We will all have to pass the baton on to the next person at some point and with everyone's help we can accomplish smooth transition with better continuity for those who follow us in service to NCSG and it's members.


