Chimney sweeps in Region 1 share that with the fall season upon us and their customers looking for ways to lower their heating expenses, customer awareness of the federal consumer tax credit for fuel-efficient stoves and fireplace inserts has been a blessing. With the new tax credit, there's really never been a better time for homeowners to hire their professional chimney service company to install a new wood or pellet stove.

The economy is still being referred to as the most significant factor in the slow start up of the traditionally busy time of year for chimney sweeps in the Northeast. Toward the middle of September, sweeps began sharing an increase in their call volume but state that the current volume is less than it was a year ago at this time (the fuel crisis was driving sales and service calls last fall).

Region Eight Report

Currently, member sweeps total 2 in the state of Hawaii, 1 in Arizona, 2 in Nevada, 4 in Utah and 57 in the state of California. That's a total of 66 region eight members. That's a four member decrease since my last report in August 2009, and a 35% lose of members from this region alone since May of 2006.

Many, if not all parts of the region have been hit hard by the currant financial crises and this has certainly impacted the chimney sweep trade. Consumers are loosing their jobs, credit is restricted and the loss of equity in homes only adds to the slide.

The "Golden State Chimney Sweep Guild" remains the only state guild within region 8. The GSCSG is held its 27th annual convention and trade show in Bakersfield, CA last month. There was four days of education available to sweeps yet only eight members bothered to show up. Member numbers are down significantly in this regional guild as well with only 48 current individual members listed on the web site representing only 40 companies state wide. The GSCSG does a great job keeping local sweeps connected and providing workshops and educational opportunities to sweeps in region eight. Members must participate in these events or this organization of over 25 years will become a memory.

The NFPA 31 committee is currently voting on the proposed changes for the 2010 edition of NFPA 31. I have included in this report the changes that are of interest to the chimney industry. The changes that the NCSG rep (me) proposed are on the top line. Where you see *Committee Meeting Action* that mean it was a hand vote (the first of 3 votes) When the committee does the official paper ballot vote it moves onto the NFPA membership, which almost goes with the committee recommendation. When the final ballots officially known I will inform you.

Report on Proposals – November 2010 NFPA 31

31-9a Log #CP9

Technical Committee on Liquid Fuel Burning Equipment, (John Pilger, rep NCSG)

Revise 6.5.7 to read: "The connector, for its entire length, shall not be smaller in effective cross-sectional area than the flue collar of the appliance, as delivered or as modified in accordance with the manufacturer's instructions. Any change in size made to accommodate a chimney lining system shall be done at the connection to that system."
Substantiation: This clarifies where a change in effective cross-section is allowed to be made. Committee Meeting Action: Accept

31-9b Log #CP10

Technical Committee on Liquid Fuel Burning Equipment, (John Pilger, rep NCSG)

Revise 6.5.9 to read: "Where insulation of the chimney connector is required to maintain the temperature of the combustion products, an insulated Type L chimney connector <u>or a factory-built chimney connector</u>

listed for the purpose shall be used."

Substantiation: This addition is made to recognize other available products that meet the intent of this provision.

31-9c Log #CP11

Technical Committee on Liquid Fuel Burning Equipment, (John Pilger, rep NCSG)

Revise 6.5.20 to read: "Connectors for appliances installed in attics or crawl spaces shall be of either a Type L vent material, <u>chimney connector or a factory-built chimney connector listed for that purpose</u> or the appliance shall be attached directly to the chimney." **Substantiation**: There are now available listed chimney connectors that will maintain flue gas

temperatures at acceptable levels and are acceptable for appropriately reduced clearances to combustible construction. These should be allowed to be used. Committee Meeting Action: **Accept**

31-9d Log #CP12

Technical Committee on Liquid Fuel Burning Equipment, (John Pilger, rep NCSG)

Add new 6.5.28 to read:

"Single-wall connector pipe shall be installed in accordance with one of the following:

(1) the appliance manufacturer's instructions

(2) with the crimped end towards the chimney"

Substantiation: This new requirement will provide a smoother flow of flue gases from the appliance to the chimney and will prevent leakage of same into the building. Committee Meeting Action: Accept

31-9e Log #CP13

Technical Committee on Liquid Fuel Burning Equipment, (John Pilger, rep NCSG)

Add new 6.5.29 to read: "The minimum thickness for steel pipe connectors shall meet the requirements of Table 6.5.29. Table 6.5.29 Minimum Thickness for Steel Pipe Connectors Thickness, Pipe Diameter, in. Sheet Metal Gauge up to 9 26 > 9 up to 10 24 >10 up to 16 22 > 16 16" Substantiation: The new table clearly defines the appropriate metal thickness for various diameters of steel pipe. These are based on current industry use and proven performance over time.

31-9f Log #CP14

Technical Committee on Liquid Fuel Burning Equipment,

Revise 6.6.7 to read: "Prior to the installation of a new or replacement oil burner or oil-burning appliance, the installer shall perform a visual inspection of the chimney and flue gas venting system and shall verify the proper size of the chimney or flue gas venting system. (See Annex E for additional information.)"

Substantiation: Annex E should be referenced to provide guidance on sizing of the flue gas venting system for the

appliance being installed. With the introduction of new technology and higher efficiencies, flue gas temperatures are

lower than previously experienced. Guidance is necessary and the reference to Annex E. Committee Meeting Action: **Accept**

Committee Meeting Action: Accept

31-9g Log #CP15

Technical Committee on Liquid Fuel Burning Equipment,

Revise 6.7.3.2 to read: "The flue gas outlet of an appliance <u>other than a direct vent appliance</u> shall terminate at least 4 ft (1.2 m) below, 4 ft (1.2 m) horizontally from, or 1 ft (0.3 m) above any door, window, or gravity air inlet of the structure and also shall terminate at least 1 ft (0.3 m) above grade. Also, delete 6.7.3.4, 6.7.3.5, 6.7.3.6.

Substantiation: These changes establish uniform requirements for the purpose of limiting the risk of carbon monoxide

contaminated gases from being drawn into the structure. The deleted paragraphs are now redundant. Committee Meeting Action: Accept

4 calls were reported during the month of August.

I have a few recommendations for the future of TAC:

- Technical assistance to members should be converted to a Frequently Asked Questions page in the Members section of the website. An e-mail address should be provided for additional assistance.
 - Since most, perhaps all, manufacturers and/or distributors offer technical assistance for their products a full time, on call technical assistance service not needed. Call volume supports this position.
 - The current structure of the TAC, and the lack of consistent recording and reporting of calls, may leave the Guild open to potential liability. A web/e-mail based system would offer the benefit of recording all web page vists, e-mail requests, and replies.
- The TAC may need to be reduced in size. An SOP should be published, and should require that members actively fulfill obligations of membership, or they will be dropped.
- Implementation of our program to offer a stipend for published articles and Q & A's is underway.

Membership Committee Report

The membership committee has taken on the task of achieving the goal of the board of directors to increase membership to 1500 by the 2015 convention. We have obtained a list of companies who perform chimney work who are not members of our Guild and they are the primary focus of our efforts at this time. We are planning to employ an integrated marketing campaign to achieve these goals.

An important part of the campaign will be retention of current members. For lack of a better analogy it is like trying to fill a bucket with a leak in the bottom. It doesn't matter how much you put in the top of the bucket if it is running out the bottom as fast as you are putting it in the top. By increasing retention we make the leak out the bottom smaller and the bucket will fill faster.

We will be sending quarterly post cards to prospective members the first having gone out in mid October. We have retained the services of a call center to follow up on these post cards and recruit the potential members. The call center efforts commence early in November. Results of this early effort will determine our actions as follow up to the future quarterly mailings.

Because retention is such an important part of the effort there are several endeavors in process to increase service to existing members. To name only two of the things we are working on. There is a new contest this year that will utilize the prevalence of YouTube in many people's minds to increase awareness of our trade. In addition Public Service Announcements are being developed for use by membership. We are very excited about the possibilities to provide ways for our members to grow their business.

We welcome ideas from members to both increase new members but also ideas of how to better serve our existing members. Please feel free to share with me any ideas you have.
